## Pet Shuttle Agreement

### Services

The ***Bark Bus Pet Shuttle*** is offered Monday through Friday. Restrictions may apply during certain holidays. Drop off and pick up locations will be within a 10 mile radius of the Canine Country Club of Arkansas, located at 26807 Goodson Rd, Roland, Arkansas ("CCC), or a location mutually agreed upon in writing by Bark Bus Pet Shuttle and the Client. Individual requests of different use of the ***Bark Bus Pet Shuttle*** can be made in advance for an additional charge.

### Terms of Agreement

This Pet Shuttle agreement is between ***Bark Bus Pet Shuttle*** and Client for pet shuttle services described above.

#### **Bark Bus Pet Shuttle's Representations:**

1. ***Bark Bus Pet Shuttle*** agrees to provide pet transport services to Client in a reliable, trustworthy, and caring manner.
2. The Pet will be secured into his or her own sturdy crate that will be secured in the vehicle.
3. ***Bark Bus Pet Shuttle*** warrants to the Client that the driver of the ***Bark Bus*** will have an active driver's license in the State of Arkansas, or any other state while actively transporting the pet.

4. **Bark Bus Pet Shuttle** will carry liability insurance relative to the services performed for the client.
5. **Bark Bus Pet Shuttle** accepts no liability for a Pet which is abandoned under this service due to non-acceptance of the Pet at the delivery address for whatever reason or due to a failure of Client or his or her designated agent to complete collection of the Pet. In the event that the Pet is abandoned, the **Bark Bus Pet Shuttle** will make every attempt to contact the Client with the contact information provided by the client. After 30 days of abandonment, the Pet will be rehomed or surrendered to a local shelter.
6. The **Bark Bus Pet Shuttle** will make reasonable efforts to contact the Client prior to obtaining any emergency veterinary care.

#### **Client's Representations:**

1. I authorize **Bark Bus Pet Shuttle** to perform transport services as outlined in this Agreement, including as set forth on Attachment A.
2. I authorize **Bark Bus Pet Shuttle** to obtain any emergency veterinary care that may be necessary during the time spent with Pet. I accept responsibility for any charges related to this emergency care. I also authorize **Bark Bus Pet Shuttle** to utilize an alternative veterinarian in the event my primary veterinarian is unavailable. I agree to reimburse **Bark Bus Pet Shuttle** for any additional fees for providing emergency care, as well as, any expenses incurred for unexpected transportation or supplies.
3. I will be responsible for all medical expenses and damages resulting from any injury to the **Bark Bus Pet Shuttle** Parties by the pet. I agree to indemnify and hold harmless **Bark Bus** Parties in the event of a claim by any person injured by the pet.
4. I attest to the fact that all licenses and vaccinations required by the state of Arkansas, the city in which I reside and/or County is current according to the law.
5. I am responsible for providing a sturdy leash to be used to properly load the Pet into the shuttle.
6. If I am unable to meet the shuttle at the designated pickup time, I agree to provide **Bark Bus Pet Shuttle** with the name of my agent before I release my Pet to **Bark Bus Pet Shuttle** and/or Canine Country Club.
7. It is expressly understood that the Client retains the services of **Bark Bus Pet Shuttle** as a separate company from Canine Country Club of Arkansas.
8. Indemnification. I expressly waive and relinquish any and all claims against **Bark Bus Pet Shuttle**, Canine Country Club, and their employees, agents, or other representatives, for any and all damages, liabilities, claims, losses, whatsoever resulting from use of the services provided herein, except those arising from willful negligence of the **Bark Bus Pet Shuttle** Parties.

#### **Cancellation or Early Termination**

1. Cancellation by the Client without notice may be charged at the full rate. Cancellation by the Client of scheduled transportations with less than 24 hours' notice may be charged at the full rate or rescheduled at the discretion of **Bark Bus Pet Shuttle**.
2. Should Pet become aggressive or dangerous, **Bark Bus Pet Shuttle** may terminate this agreement upon reasonable notice to Client.
3. Any wrongful or misleading information in the Client's information or Pet Information Sheets may constitute a breach of terms of this agreement

and be grounds for termination.

4. A Pet not picked up by the designated time will be transported back to the Canine Country Club for pick up. If the Pet is not picked up at Canine Country Club by closing time, the Pet will be boarded and client will assume boarding charges on top of Shuttle charges due under this agreement.

**Confidentiality**

The Parties agree that they shall not disclose any terms and conditions contained in this Agreement to any other party and shall keep same confidential between them.

**Miscellaneous**

No relaxation, indulgence, waiver, or release by any party of any of the rights in terms of this Agreement on one occasion shall prevent the subsequent enforcement of such rights and shall not be deemed to be a waiver of any subsequent breach of the terms. This Agreement shall be governed by the laws of the State of Arkansas.
